



Waiver and Safety Guidelines

This Waiver and Release of Liability ("Waiver") is executed by the undersigned participant or the parent/legal guardian of a minor participant considering the services provided by 2636906 ALBERTA LTD O/A Jump and Joy and in compliance with Alberta Safety Guidelines regarding inflatable amusement devices. By signing this Waiver, I acknowledge that I have read, understood, and agree to follow the safety regulations outlined below.

1. Acknowledgment of Risks

I understand and acknowledge that using the Bouncy Castle involves risks and hazards, including but not limited to:

- Physical injuries such as falls, collisions, or sprains.
- Equipment malfunctions or weather-related hazards.
- Potential harm from improper use or failure to follow safety guidelines.

I voluntarily assume all risks associated with using the Inflatable, as outlined by the Company and following Safety Guidelines.

2. Waiver of Liability

I, on behalf of myself, my minor child (if applicable), and our heirs or assigns, waive and release **Jump and Joy**, its owners, employees, and representatives from any liability, including claims, demands, or damages for personal injury, property damage, or death that may arise from the use of the Bounce House. This waiver includes negligence claims but does not apply to gross negligence or willful misconduct by the Company.

3. Safety Compliance and Supervision

I agree to the following safety requirements:

- **Adult Supervision:** Adult supervision is always required while the Bounce House is in use.
- **Anchoring:** The Bounce House must always be securely anchored to prevent tipping or movement.
- **Controlled Entry:** Riders must enter and exit the Bounce House orderly. Overcrowding or exceeding capacity is prohibited.

- **Rider Age and Weight:** Riders must adhere to age, height, and weight restrictions. Older children and adults are not permitted to play with younger children.

4. Prohibited Items and Activities

The following are strictly prohibited within the Inflatable, as per Alberta guidelines for safe use:

- **Sharp Objects:** No shoes, glasses, jewelry, or sharp objects.
- **Food and Pets:** No food, drinks, gum, pets, or silly string.
- **Dangerous Behavior:** No somersaults, flips, diving, wrestling, or rough play.
- **Blower Access:** Patrons must always remain clear of the blower and power supply.

5. Weather Conditions and Equipment Safety

Per safety regulations, I understand the importance of following weather-related safety protocols:

- **Weather Restrictions:** The Bouncy Castle must be immediately deflated and unplugged if wind speeds exceed 15 mph or in the event of rain or other severe weather.
- **Equipment Safety:** Any observed equipment damage or improper installation must be reported to **Jump and Joy** immediately, and use should be discontinued until resolved.

6. Health and Medical Conditions

I understand that individuals with health concerns such as pre-existing conditions (neck, back, heart issues, etc.) should consult a physician before participating. I agree that neither my minor child nor I (if applicable) have any conditions that prevent safe use of the Inflatable.

7. Emergency Procedures

In the event of an emergency, I agree to comply with the following protocols:

- **Evacuation:** Exit patrons in an orderly manner.
- **Turn Off and Deflate:** Power down and deflate the Bounce House in severe weather or equipment failure.

8. Indemnification

I agree to indemnify and hold Jump and Joy and its employees harmless from any claims or damages, including those made by third parties, arising from my or my minor child's use of the Bouncy Castle. This includes damage to property or injury to others due to a failure to follow the rules or safety guidelines

9. Maximum Capacity and Rider Limits

I acknowledge the maximum capacity and rider limits for the Bouncy Castle, as stated by the company

- **Riders by Age Group:**
 - 2-4 years: 10-12 riders.
 - 5-8 years: 8-10 riders.
 - 9-12 years: 6-8 riders.
 - 13-16 years: 4-5 riders.
- **Weight Limit:** Maximum total weight is 1000 lbs.
- **Height Restrictions:** Riders must be between 36" and 70" in height.

10. Severability

If any provision of this Waiver is deemed invalid, the remaining provisions shall remain in full force and effect.

11. Agreement and Signature

- I fully understand this Waiver and the safety guidelines per Alberta regulations. By signing, I agree to comply with all the terms and conditions and acknowledge that failure to adhere to these guidelines may result in the immediate termination of use without a refund.
- I have carefully reviewed and fully understand the Operator/Attendant Responsibilities and Emergency Procedures provided above. By checking the box below, I confirm my agreement to adhere to all terms, conditions, and safety guidelines outlined in this document.
